## INFORMATIVA Ai sensi dell'art. 13 del decreto legislativo n. 196/2003, recante disposizioni sul nuovo "Codice in materia di protezione dei dati personali" (Privacy law)

We inform you that the data you provide will be processed in compliance with the legislation mentioned above and with confidentiality obligations. These data will be processed for institutional purposes, therefore, strictly connected and instrumental to the activity of the A.S.D.

The data processing will be carried out in an automated and manual form by subjects specifically appointed for this purpose; to this end, the tools used and the methods of treatment will be suitable to guarantee the security and confidentiality of the data.
